I am directed to state that "**All India Forward Bloc**" a registered recognized political party in the State of West Bengal, having reserved symbol "**Lion**", in the said State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol '**Lion**' to the candidates being set up by the said party at the current general election to the Legislative Assembly of Uttar Pradesh from **30-Bilari, 33-Sambhal, 39-Dhanaura(SC), 127-Pilibhit and 128-Barkhera** Assembly Constituencies , going to poll in the 7th Phase of the elections.
