I am directed to state that “**All India Forward Bloc**” a registered recognized political party in the State of West Bengal, having reserved symbol “**Lion**”, in the said State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Lion**’ to the candidates being set up by the said party at the current general election to the Legislative Assembly of Uttar Pradesh from **30-Bilari, 33-Sambhal, 39-Dhanaura(SC), 127-Pilibhit and 128-Barkhera** Assembly Constituencies , going to poll in the 7<sup>th</sup> Phase of the elections.

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidate set up by “**All India Forward Bloc**” at the



general election to the Legislative Assembly of Uttar Pradesh from **30-Bilari, 33-Sambhal, 39-Dhanaura(SC), 127-Pilibhit and 128-Barkhera** Assembly Constituencies, going to poll in the 7<sup>th</sup> Phase of election shall be allotted the symbol "**Lion**".
