I am directed to state that “**All India Forward Bloc**” a registered recognized political party in the State of West Bengal, having reserved symbol “**Lion**”, in the said State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Lion**’ to the candidates being set up by the said party at the current general election to the Legislative Assembly of Uttar Pradesh from **166-Bhagwantnagar, 169- Bakshi ka Talab, 170-Sarojini Nagar, 171-Lucknow West, 172- Lucknow North, 173-Lucknow East, 174-Lucknow Central, 175- Lucknow Cantt., 176-Mohanlalgang (SC) , 180-Rae Bareli, 198- Kanauj (SC), 213-Shishamau and 214-Arya Nagar** Assembly Constituencies , going to poll in the 4th and 5th Phases of the elections.
