I am directed to state that “**All India Forward Bloc**” a registered recognized political party in the State of West Bengal, having reserved symbol “**Lion**”, in the said State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Lion**’ to the candidates being set up by the said party at the current general election to the Legislative Assembly of Uttar Pradesh from **328-Chillupar, 350-Didarganj, 351-Lalganj(SC) and 377-Zahoorabad** Assembly Constituencies , going to poll in the 2nd Phase of the elections.

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidate set up by “**All India Forward Bloc**” at the general election to the Legislative Assembly of Uttar Pradesh from **328-**

Chillupar, 350-Didarganj, 351-Lalganj(SC) and 377- Zahooraabad Assembly Constituencies, going to poll in the 2nd Phase of election shall be allotted the symbol "Lion". The Returning Officer may be informed that the candidates set up by "All India Forward Bloc" are eligible for the allotment of the symbol 'Lion' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
