Sub:- Allotment of reserved symbols under Para 10A of the Election Symbols (Reservation & Allotment) Order, 1968. – **Communist Party of India (Marxist-Leninist) (Liberation)**- regarding.

Sir,

I am directed to refer to the subject cited and to state that "**Communist Party of India (Marxist-Leninist) (Liberation)**" a registered un-recognized political party at present but which was a State party earlier in the State of Bihar, prior to its de-recognition as a State party, having reserved symbol '**Flag with Three Stars**' in the said State, not earlier than 6 years from the date of Notification of the current general election to the Legislative Assembly of Uttar Pradesh has requested the Commission for concession under Paragraph 10A of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol '**Flag with Three Stars**' to the candidates being set up by the said party at the current general election to the Legislative Assembly of Uttar Pradesh from 66(Sixty Six) Assembly Constituencies of the State (LIST ENCLOSED).

The Commission has decided to extend the concession sought by the party under paragraph 10A of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidate set up by the

**“Communist Party of India (Marxist-Leninist) (Liberation)”** at the current general election to the Legislative Assembly of Uttar Pradesh from 66(Sixty six) Assembly Constituencies of the State (LIST ENCLOSED) shall be allotted the symbol **‘Flag with Three Stars’**. The Returning Officers may be informed that the candidates set up by **“Communist Party of India (Marxist-Leninist) Liberation”** are eligible for the allotment of the symbol **‘Flag with Three Stars’** under paragraph 10A of the symbols order from the assemblies constituencies mentioned above, subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
