Sub:- Allotment of reserved symbols under para 10 of the Election Symbols (Reservation & Allotment) Order, 1968. – **Lok Janshakti Party**- regarding.

Sir,

I am directed to state that “**Lok Janshakti Party**” a registered recognized political party in the State of Bihar having reserved symbol ‘**Bungalow**’, in that State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Bungalow**’ to the candidates being set up by the said party at the current general elections to the Legislative Assemblies of **Uttar Pradesh, Uttarakhand, Punjab, Manipur and Goa** from all the assembly constituencies of the States.

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidates set up by “**Lok Janshakti Party**” at the current general elections to the Legislative Assemblies of Uttar Pradesh, Uttarakhand, Punjab, Manipur and Goa from all the assembly constituencies of

the States shall be allotted the symbol '**Bungalow**'. The Returning Officers concerned may be informed that the candidates set up by "**Lok Janshakti Party**" are eligible for the allotment of the symbol '**Bungalow**' under paragraph 10 of the symbols order subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
