I am directed to state that “**Muslim League Kerala State Committee**” a registered recognized State political party in the State of Kerala, having reserved symbol “**Ladder**”, in that State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Ladder**’ to the candidates being set up by the said party at the current general election to the Legislative Assembly of **Uttar Pradesh** from 20 (Twenty) Assembly Constituencies mentioned in the enclosed list.
