I am directed to refer to the subject cited and to state that “**Muslim League Kerala State Committee**” a recognized state party in the State of Kerala, having reserved symbol ‘**Ladder**’, in that state has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Ladder**’ to its candidates being set up by the party at the current general elections to the Legislative Assembly in the state of **Uttar Pradesh** from **44-Sardhana, 75-Koil, 76-Aligarh, 87-Agra Cantt., 97-Firozabad and 98-Shikohabad** Assembly Constituencies.

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election symbols(Reservation and Allotment) Order,1968.Accordingly, the candidate set up by “**Muslim League Kerala State Committee**” at the general elections to the Legislative Assembly of Uttar Pradesh from **44-Sardhana, 75-Koil, 76-**

Aligarh, 87-Agra Cantt., 97-Firozabad and 98-Shikohabad Assembly Constituencies shall be allotted the symbol "**Ladder**". The Returning Officer may be informed that the Candidates set up by "**Muslim League Kerala State Committee**" are eligible for the allotment of the symbol '**Ladder**' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
