I am directed to refer to the subject cited and to state that **“Revolutionary Socialist Party”** a recognized State party in the State of West Bengal, having reserved symbol **‘Spade & Stoker’**, in that State has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol **‘Spade & Stoker’** to its candidates being set up by the party at the current general elections to the Legislative Assembly of **Uttar Pradesh** from **44-Sardhana, 47- Meerut Cantt., 60-Garhmukteshwar, 87-Agra Cantt.(SC), 90-Agra Rural (SC), 249-Patti, 364-Badlapur, 366-Jaunpur and 372-Kerakat(SC)** Assembly Constituencies.
