Sub: Presidential Election, 2012 -Public Notice of intended election-Publication under rule 3 of the Presidential and Vice-Presidential Elections Rules, 1974.

In pursuance of rule 3 of the Presidential and Vice-presidential Elections Rules, 1974, the Election Commission of India hereby directs the Returning Officer and the Assistant Returning Officers that the Public Notice of the intended election in Form 1 annexed to those rules shall -

- (a) be published in the Gazette of India in Hindi and in English languages;
- (b) be re-published in the official Gazette of each State and the Union Territory in the language or languages in which statutory notifications issued by the State Government Administration are published in such Gazettes; and
- (c) be given publicity by Radio and Doordarshan, announcements from the Stations of All India Radio/Doordarshan Centres at New Delhi, at the State Capitals and at other places (if any) throughout the country and through all other media of mass communication.

2. The Public Notice shall also be published by affixing a copy thereof in some conspicuous places in the offices of the Returning Officer and every Assistant Returning Officer.
