## **DIRECTION**

**Subject: Vice-Presidential Election, 2012- Manner of Publication of list of contesting candidates Rule 6(b) of the Presidential and Vice-Presidential Elections Rules, 1974.**

In pursuance of clause (b) of rule 6 of the Presidential and Vice-Presidential Elections Rules, 1974, the Election Commission directs the Chief Electoral Officers of all States and Union Territories that the list of contesting candidates prepared by the Returning Officer in Form 5 appended to those Rules, shall in addition to being published in the Gazette of India, be also republished:-

- (a) in the Official Gazette of each State/Union Territory in the language or languages in which statutory notifications issued by the State Government/Union Territory Administration are published in such Gazettes; and
- (b) by affixing a copy thereof in a conspicuous place in the office of the Returning Officer/ Assistant Returning Officer.
